**Stud Dog Class.** For Stud Dogs and three of their Get. Stud Dogs must be entered in the Stud Dog Class and shown in the ring with their Get. Owner of the Stud Dog need not necessarily be owner of Get. Award will be based on the merits of the get. Get must be individually entered in one of the breed classes in this show for which it is eligible.

**Brood Bitch Class.** Same as Stud Dog, except substitute Brood Bitch for Stud Dog and Produce for Get.

Since a judge's decision in the Stud Dog & Brood Bitch Classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed by virtue of having won this class.

**Brace Class.** Each Brace shall be composed of two Dachshunds. Both dogs competing in brace competition must have at least one common owner. All braces must be entered in the Brace Class and shown in the ring at the same time. Show Brace Class as "Conf. Brace" on entry form. Registered name of the other half of the brace must be indicated on the entry form. Each dog must be individually entered in one of the Breed Classes for which an entry fee is required.
