TIME OF ROLL CALL: 12:30 PM. The trial will be run first followed by the tests.

ELIGIBLE BREEDS AND REGISTRY

Only purebred Afghan Hounds may be entered. All entries shall be registered with the AKC or have an AKC ILP number. Altered or neutered dogs may run. Hounds must be one (1) year old or older on the day of the trial.

ENTRIES WILL NOT BE ACKNOWLEDGED BY MAIL

Late, incomplete, unsigned or conditional entries will not be accepted.

EVENTS & STAKES

Events & Stakes Offered:

Junior Courser Test A and Test B

Open Stake: Open to any eligible Afghan Hound that has obtained one of the following:

- 1 an AKC Junior Courser Title
- 2 is an AKC Field Champion
- 3 Hounds disqualified from AKC may NOT enter

Veteran Stake: Open to any eligible Afghan Hound that is 6 years old or older on the day of the trial and also meets the qualifications of the Open Stake.

Specials Stake: Open to any eligible Afghan Hound which is an AKC Field Champion

AKC Conformation Champion Stake: Open to any eligible Afghan Hound that is an AKC Breed Champion and also meets the qualifications of the Open Stake. **NOTE: THIS IS A NON-REGULAR CLASS - NO POINTS ARE AWARDED FROM THIS CLASS.**

CONDITIONS

Hounds must be one year old or older on the day of the trial

Stakes shall be split each time the entry is sufficient to hold two or more five point majors.

Hounds disqualified from AKC, ASFA, or CKC Field Trials may be entered in the Junior Coursing Tests.

Bitches in season or lame hounds will be excused

Hounds not present at the time of Roll Call will be scratched

Battery powered, continuous loop lure equipment will be used. Back up equipment will be available.

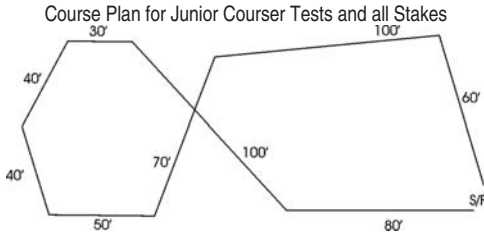
Lure will consist of plastic streamers.

"It is recommended that Junior Courser hounds entering the Open Stake for the first time have successful practice experience with other hounds before competing."

Lancaster Host Hotel to Coursing Field: (see page 39 for directions back to hotel)

- 1: Start out going WEST on US-30 / LINCOLN HWY E toward OUTLET DR. 0.5 miles
- 2: Turn LEFT onto MILLSTREAM RD. 0.4 miles
- 3: Turn LEFT onto GRIDLEY RD. 0.7 miles
- 4: Turn RIGHT onto ROCKVALE RD. 0.3 miles
- 5: Turn LEFT onto STRASBURG PIKE. 0.6 miles
- 6: Turn RIGHT onto PIONEER RD. 1.4 miles
- 7: Turn LEFT onto LAMPETER RD. 0.6 miles
- 8: Turn RIGHT onto VILLAGE RD / PA-741. Continue to follow PA-741. 2.4 miles
- 9: Turn LEFT onto PA-272 S / WILLOW STREET PIKE S. at Kendig Square shopping Center. Continue to follow PA-272 S. 4.4 miles
- 10: Turn RIGHT onto PENNSY RD. (just prior to stone railroad over-pass) 1.0 miles
- 10: Turn LEFT onto KREIDER RD. Cross bridge and stay straight to RAWLINSVILLE RD 0.1 miles
- 11: Stay straight onto RAWLINSVILLE RD., (@ 0.7 mi, bear RIGHT at CLEARFIELD RD. TO STAY ON RAWLINSVILLE RD. 2.7 miles
- 12: End at Coursing Grounds
